

## DATA PRIVACY POLICY

### Overview

This privacy policy ("Policy") is applicable to all those persons(s) whose Personal Information and/or Sensitive Personal Data/Information is collected, stored and processed by Kanji Forex Private Limited ("Company") ("You" and/or "Your"). Provided that any Information that is freely available or accessible in public domain or furnished under the Right to Information Act, 2005 or any other law for the time being in force will not be considered to be SPDI.

#### COLLECTION, USE & PROCESSING OF YOUR PERSONAL INFORMATION: Experience value 1.

Personal Information that we collect:

For the purposes of this Policy, "Personal Information" (with reference to the SPDI Rules) is any data which relates to an individual who may be identified from that data (including, but not limited to, name, address, telephone number, email address, username and password, photograph, government-issued identifier, or any other data used or intended to be used to identify, contact or precisely locate an individual or device), that You voluntarily submit it to us (including in relation to enquiring about career opportunities or applying for a job through our website), or from a combination of a set of data, and other information which is in possession of the Company.
